It was moved by Commissioner Hull, seconded by Commissioner Goodlett to approve the minutes from the June 20, 2017 Planning Commission Meeting. The motion carried unanimously by roll call vote.

IV. MEETING ITEMS

- A. A continued public hearing was held to consider Minor Amendments to Camas Municipal Code (CMC) Title 18 Zoning
- Details: As part of a periodic code update, the proposed minor amendments to Title 18 Zoning of the Camas Municipal Code (CMC) included updates to clarify sections that may have been challenging to administer since the last review update, new additions and corrections including typos. Planning Commission conducted a public hearing on June 20th and continued the hearing to July 18th. Exhibit 1 contained amendments to Title 18 consistent with the initial recommendations of the Commission, with exceptions as noted in the recommendation below. Exhibit 2 included the full record of the June 20th public hearing. Exhibit 3 included an exhibit as requested by the Commission. Additional public comments by Ms. Poe are included at Exhibit 4. Sarah Fox and Phil Bourquin reviewed the proposed minor amendments to the CMC Title 18 Zoning and introduced documents into the record.

Staff responded to the Commissioner's inquiries. Discussion ensued.

Chair Beel opened the public testimony portion of the hearing at 7:18 p.m.

Melanie Poe, 1806 SE 202nd Avenue, Camas, spoke in favor of staff's recommendation for CMC 18.07.030 Table 1, Note 10 as outlined in Exhibit 6.

The public testimony portion of the hearing was closed at 7:20 p.m., as there were no others who wished to speak.

It was moved by Commissioner Hull, seconded by Commissioner Hein to forward a recommendation to City Council to approve the proposed amendments to Camas Municipal Code Title 18 Zoning consistent with Exhibit 1, with the exception of Notes 10 and 11 of CMC18.07.030 Table 1; revising Note 10 to read as stated in the July 18, 2017 Community Development Director's Memorandum (Exhibit 6) and Note 11 will read: "Conditional use permit is required if facilities for kennels are proposed outdoors." In addition, Planning Commission recommends approval to City Council for amendments as illustrated in "Exhibit 3 Corrected" and "Exhibit 5 Revised Density Table". The motion carried unanimously by roll call vote.
