The City of Camas through Ordinance No. 16-015 adopted a moratorium on the establishment of Wireless Communication Facilities on September 6, 2016, together with a work plan for reviewing its regulatory options regarding Wireless Communication Facilities under zoning and use codes.

Staff has provided a report to summarize the proposed CMC amendments along with two attachments of the same proposal, only illustrated differently. Attachment 1 shows the draft changes as strike-though text or underlined. Attachment 2 provides the amendments without any mark-ups.
