#### I. CALL TO ORDER BY CHAIR

Chair Smith called the meeting to order at 1:03 p.m.

## II. APPROVAL OF THE MINUTES

It was moved by Vice-Chair Durgin, seconded by Council Member Chaney, to approve the meeting minutes of May 9, 2018. The motion carried unanimously.

#### III. RECONSIDERATION OF DENIAL OF SERVICES

Administrative Services Director Gorsuch informed the Board that the City received a request for reconsideration from Deloy Little's family regarding the decision that was made by the Board during the May 9, 2018 meeting.

### A. Appeal of Retiree Coverage Request

MacPherson stated that the record was supplemented with materials provided by the family and will be entered into the record and noted as an exhibit for this reconsideration hearing.

It was moved by Council Member Chaney, seconded by Vice-Chair Durgin, to grant the request for reconsideration of services to 24 hours for Deloy Little through October 15, 2018. The motion carried unanimously.

MacPherson spoke on behalf of the Board and thanked the family for the additional information provided. He explained the Board's dilemma to the family regarding the need to establish the medical necessity of the request and provided the family with information regarding the Board rules in relation to nursing home confinement and potential options to consider in the future.

Findings will need to be issued to the family regarding the Board's decision.

MacPherson also provided additional information regarding the Camas LEOFF Disability Board Rules and Procedures as outlined in the manual.
