#### **SUPPLEMENTAL - Written Questions for Mayoral Candidates – October 2018**

1. My vision for Camas five years from now builds upon the successes of the Camas of today. Specifically, Camas would have: an engaged citizenry that understands the city's goals and strategic plan; consistency across all processes, based on strong policies; motivated employees that feel valued and empowered to make decisions – working as one team for community benefit; fiscal stability with investment in asset management and future replacement needs; partnerships with other taxing districts and non-profits to provide services when appropriate; and, a continued sense of community pride.

I will lead the community toward my vision through enhanced utilization of our strategic plan. The current strategic plan would be reviewed and updated in preparation for decisions to be made in 2020 and during 2021-22 budget development. The extended process will allow for broad input from citizens, business groups, city staff, and non-profits to help determine goals for the city. The City Council will not only be involved in development of the goals but will ultimately prioritize the goals.

Every action the city takes, financial and policy, will be weighed against the strategic plan. Every document will reference the objective that supports the strategic plan until it is second nature to know exactly what goal the city is trying to accomplish. Knowing what the city's goals are and seeing the Mayor, City Council, and staff all making decisions in support of the goal will provide stability and consistency. The community will have participated in the planning process and understand the goals. Staff will be empowered to make decisions because the goals and path of the city will be clear. And City Council will more easily determine where to place budget and which partnerships to pursue based upon the goals.

I look forward to engaging in this process. My personal vision includes movement toward a community center – I hope the community agrees!

- 2. I have worked in budgeting, forecasting, and performance improvement of local governments for over twenty years. This experience ranges from responding to constituent letters in the Ombudsman's Office to reviewing municipal budgets for legal compliance to presenting before the legislature for additional money or personnel. I have observed and learned from many different public officials in nearly all municipal service areas and have a good understanding of government operations. I have supervisory experience and have a strong desire to see the employees grow and reach the professional level that they aspire to. I know that I am only as good as the people that surround me. Finally, I want to continue to learn and use that knowledge to build upon the success that Camas has already achieved.
- **3.** The city should address budgetary difficulties through a balance of revenue enhancement opportunities and expenditure reductions. It is easy to say that revenue can be raised through increased taxes or fees; I agree that user fees should equal the cost of providing service but maybe raising fees is not the only answer. If the goal is increased sales tax revenue, for example, then instead of raising the tax rate maybe the city should look at how to expand its retail base is it through funding storefront improvements for small business owners to entice customers to their store? Maybe it is through economic development incentives that would encourage more retailers to locate their stores here? I am not sure of the answer but I would explore all of the options to enhance revenue.

On the expenditure side, city departments initiated a level of service study to help determine needs for the 2019-20 Budget. I would ask city staff to continue this process by reviewing current services and classifying them as mandated/core or livability/desirable services. Using this information in concert with

the strategic plan discussed in question one would help identify areas where the city could reduce services with minimal impact and would also highlight areas where additional funding was needed. If additional funding fit within the community's goals but there was insufficient funding then it should be directed to the citizens for a vote.

**4.** The most significant challenge is communication. I think if this challenge were settled then other challenges would also be resolved.

In 2011, the City engaged in ward meetings to communicate with citizens. While some of the meetings were well attended, attendance overall was weak and at the final ward meeting only one citizen and her child attended. I understand why the decision was made to end ward meetings and the subsequent use of social media to communicate the city's message. Facebook and Twitter are excellent communication tools but they can also allow for disengagement. Without face-to-face contact it is difficult to have discussions about an issue or why decisions are made. Instead, assumptions travel throughout the internet; small problems become big problems and attitudes turn toward distrust.

I would address this challenge by adding ward meetings back into the city's communication toolbox. I would also like to develop a Camas 101-type academy as seen in the MRSC magazine. I envision an eight class "school" where citizens can learn about the City of Camas – the services we provide, how we pay for services, and – again – goals for the city. Graduates of the school would become ambassadors for the city and help end the communication challenge.

5. Due to space limitations I will only list the Public Service/volunteer activities outside of City Council.

Office of the Ombudsman, Mayor Vera Katz 1993 – 1994; Respond to constituent letters, Senator Ron Wyden 1997; Finance Committee, City of Troutdale 2000 – 2001; Board of Adjustment, City of Camas 2004 – 2011; PTA/PTO various roles (President, Treasurer, Dance Chair, Carnival Chair) 2004 – 2014; Participant, Camas School District Citizen Advisory Council 2004 – 2007; Girl Scout Leader 2005 – 2008; Basketball Coach, Camas Parks & Rec and Camas Community Ed 2005 – 2011; Cheer Coach for East County Pop Warner 2011; League and Board Treasurer, Pop Warner 2008 – 2011; Participant, Leadership Clark County 2009 – 2010; Kennel Cleaner, West Columbia Gorge Dog Shelter 2010 – 2018; President, Partners with Camas Parks and Recreation 2015 – 2018; Support Camas High School (hand out textbooks, review senior boards, grad night) 2012 – 2018; Support Camas community (hand out meals at Thanksgiving, Christmas Eve breakfast, downtown cleanup). Basically, anything to support my children!

**6.** In 2002, I hoped to serve as a City Councilor in the City of Troutdale and submitted my application to that city. However, within a short time after filing the paperwork my family chose to move to Camas and I withdrew my application. Disappointed that I would not be able to participate on city council as I had hoped I immediately made an appointment with Lloyd Halverson and asked how I could be involved in my new city. I applied for and did not get appointed to the planning commission but was able to serve on the Board of Adjustment for many years before joining the Camas City Council.

- **2.** What experiences, talents or skills would you bring to the community that you would like to highlight?

1. What is your vision for Camas five years from now?

My vision for Camas has been, and will continue to be, one of the most livable communities possible. This includes well-thought-out residential development that includes open spaces, good traffic flow and non-dictatorial design standards. It also includes continued support of our corporate citizens and partnering with them whenever possible to aid them in expansion or, in the case of new companies, relocating or constructing.

My role would be to engage our staff in these goals and support them with personal involvement whenever appropriate.

2. What experiences, talents or skills would you bring to the community?

My resume pretty well outlines my experiences. One "talent" or "skill" comes from my years of involvement in participatory management. I am very good at listening to others, speaking with them and coming to a mutual agreement or decision. I am very much a "let's do what's best" person.

3. Explain your views on how the City of Camas should address budgetary difficulties.

The first obvious step is to keep very close tabs on expenditures. Any that are not contractually mandated should be given extra scrutiny as to actual need. There are often ways to cut costs that won't hamstring operation of the City.

Income, as the question indicates, is limited by law. The City should continue to look for partnerships that will allow us to reduce expenditures for necessary services. A facet of that would to be absolutely sure the service is really Necessary. We sometimes do things just because we've always done them.

Continuing recruitment of industry and businesses is also a high priority. They can create a new source of taxes that can ease the pain to some degree.

4. What are the most significant challenges other than finances facing the City of Camas today?

I think one of the most significant challenges is the possibility of a complete shutdown of the paper mill. We need to begin working on a long range plan that incorporates the examination of subsidiary impacts of it's shutdown. The lake, the dam (water control), what portions of their process are complementary to ours, etc. And, last but most important, develop a comprehensive plan for ultimate use of the site if it is vacated.

Secondarily, I think the continued acquisition of open space for public use and parks will become more of a challenge in the future. We need to continue to prioritize that need and work with developers and citizens to accomplish it.

And, with continued growth - we need to maintain the current quality of our infrastructure through partnering with developers during build out and pursuing funding through state and federal sources.
