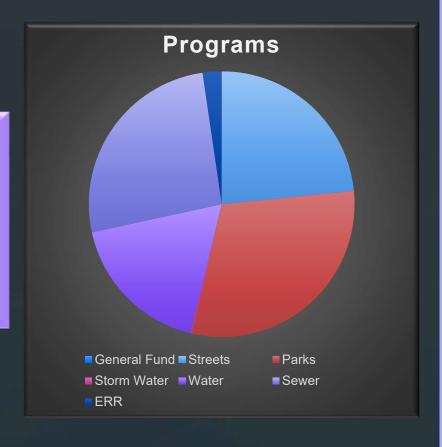

- 43 packages for \$8,037,196
 - Carry Forward 25 packages (\$9,961,903)
 - Administrative 8 packages \$900,000
 - Supplemental 9 packages \$1,024,707



Different Approach in 2017-2018

- 2018 Re-Adoption for Capital essentially was unchanged from the biennial budget.
 - Minimize the budget changes with expense estimates over year-end
- Reconciled carry forward estimates in February
 - Year-end accruals taken into consideration
- Reviewed with departments
 - Timing and Resources evaluated

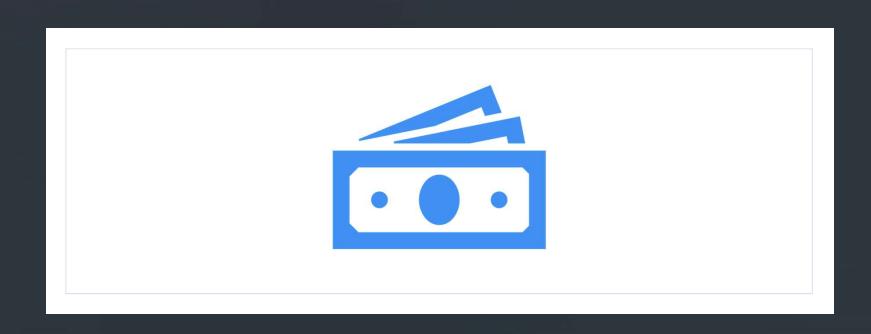
