Hello Jeff,

I live right above Feast 316, so where I generally try to park is on Dallas St, 4th and Everett.

This is often challenging because these zones are marked as 2 hour parking. This 2 hour limit is where my tickets have come into play. Specifically, they have all been related to not moving my car every 2 hours on one of these streets.

You might be thinking, "just park on one of the unmarked streets." In theory the easy solution is exactly that. Franklin St. by the library is a great option; however, when I attempt to do this during a weekday all of these spots are full and don't seem to clear up until after work hours (around 5:00pm).

I have thought of a couple ideas, but I'm sure with your background you will have far better ones than myself. Here are a few I have thought through...

• For downtown residents to be given a "parking pass" that enables registered car to park for longer than 2 hours on designated streets without a ticket.

- More options than just 2 hour parking in downtown. For example 2 hour, 4 hour and 6 hour parking. This might be problematic, but might also have potential.
- Removing the 2 hour signed spots on Everett street completely

• Work with local stores to establish rented parking spots in specific parking lots for downtown residents only (for example: behind 4Ever Growing Kids, Lutz Hardware, US Bank, Bank of America etc.)

I'm hoping this helped clarify some of the parking issues I'm having so you can better assist me in next steps. If you have any additional questions I think email is the best way for us to get in touch, given our schedules.

Thanks for reaching out and your attentiveness on my parking and ticket problems. I look forward to seeing what happens next.
