As a resident of Camas for over 11 years I have seen many positive changes to our community, largely in part due to decisions made by former and current Council Members. I care about our community and my family loves living here. As my daughter grows, I like the thought of her calling Camas her hometown. I would be honored to represent and serve those who live in the 3rd ward as well as having the opportunity to have a positive impact on our community.

2. What experiences, talents or skills would you bring to the Council and community that you would like to highlight?

I am an award-winning business professional with solid leadership experience. I am accustomed to working with people from all walks of life and with diverse backgrounds. I have proven ability to adapt to changes and new challenges while focusing on the bigger picture. I am effective at building rapport and connecting with people at all levels. I have skills that include budgeting, strategic planning, operations management and negotiations.

3. Camas, like many Washington cities, are facing a structural deficit, where expenses grow faster than revenues, due to property tax limitation measures. Explain your views on how the City of Camas should address these budgetary difficulties. Specifically, discuss actions you might encourage to balance revenues and expenditures and the impacts of City services.

I feel this is one of the biggest challenges facing cities in Washington state. I would suggest measuring the current costs and the future benefits of each project while keeping a focus on maintaining our community standards. Setting short term and long-term priorities based on available funding. Safety must be a priority in these reviews and covers many facets of our government. I would be better suited to answer this question after a thorough review of the budget and subsequent challenges/shortfalls.

4. In your opinion, excluding finances, what are the most significant challenges facing the City of Camas today? How would you propose to address these challenges?

In my opinion the most significant challenge facing the City of Camas (short of financial concerns) is the increase in development throughout the city limits, including the Columbia Palisades and several additional residential developments. The challenge in maintaining a sound infrastructure that can support these developments will increase overtime. These challenges will include maintaining the quality of the education in our schools (that we have all come to appreciate), vehicle traffic and the strain on our government services i.e. Public Safety, Fire and Rescue. To address the challenges the City Council will need to work closely with these identified agencies to evaluate their priorities and develop strategic plans to address the concerns.

5. What forms of Public Service or Volunteering have you been involved in? Provide details regarding the dates, roles and responsibilities.

Over my career I have been involved with The Portland Metro Rotary from 1996 to 2002. Our focus was on services for Children and preserving public areas in the Portland Metro community. Some projects involved restoring an inner-city community park, raising funding for the Tucker Maxon school, which focuses on children with auditory-verbal impairments. I have also volunteered for the Columbia Slough Watershed Council 2008-2013 helping with slough restoration and educating school age children on the ecosystem within the watershed. Most recently I have volunteered with Santa's Posse 2017 providing families in need with gifts during the holidays.
