1. Why do you want to serve on the City Council?

I have a passion for the City of Camas, the community, our local neighborhoods and the people of the area. I want to participate on the City Council to help preserve the heritage of the City, while being involved in the vision and direction of the area as it incrementally grows in the future. As a Council Member, I feel I can provide value based on my personal and professional experience to address the needs/challenges of the community such as; providing quality city service levels in the face of increased growth, balancing the financial budget in a capped environment, maintaining and increasing the livability of the area, developing economic growth and job creation and keeping our community a safe place to live. I want to serve to help maintain the City as the greatest place to live in Clark County, and give back my time to the citizens.

2. What experiences, talents or skills would you bring to the Council and Community?

I have extensive business experience over the past 25 years in the Bio/Medical Field. I have direct experience in business development, working collaboratively on boards/panels, balancing large revenue bases (200M+), budgeting and P/L responsibility, managing large/diverse projects with many stakeholders and leadership initiatives. I have a strong educational background graduating with honors from High School, BS Degree in Business/Economics and MBA. I've dedicated my time to my local neighborhood – Prune Hill Park HOA, participated on the Board for 8 years, President for last 5 years. Our neighborhood has many operational duties with expansive private green spaces, private roads, paths and storm water facilities representing 131 homes. I feel the Association is operating well under my leadership; maintained, up-to-date on annual projects, balanced budget with reserves, good communication and happy home owners. Please see enclosed recommendation letters. I have good written and verbal communication skills, and work well with others in a team environment. I feel I possess the skills to work well with the Mayor, Council, City, Businesses and Citizens of Camas.

3. How should Camas address these budgetary difficulties? What actions might encourage the balance?

I understand there's challenges when a municipality faces structural deficits when expenses outpace revenues and the City needs to provide high quality services to the community. The actions to address these issues are many-fold:

- The City/Council needs to prioritize the most important services and monitor the performance levels.
- For the designated "Most Important Services", operating efficiencies and expenses need to be continually monitored. Process improvements need to be implemented, and lean systems utilized for optimization.
- Examine non-essential services and look at ways to trim expense levels as needed.
- Look at the future revenue and growth initiatives, and evaluate the expenses needed to provide services for the increased growth (infrastructure improvements, sewer, maintenance, EMS, police, city services).
- On the revenue/supply side, evaluate ways to generate additional revenues (Utility Rate Schedule, Additional Taxes on Specified Utilities, Impact Fee Schedule, Property Tax Cap, Vehicle Licensing Fees, Lodging Tax).

- **3. Continued** Expansion of growth boundaries and land development for single family and multi-unit dwellings to increase property tax revenue. Urban growth and planning commission initiatives.
- Solicit economic development initiatives to increase businesses locating and building in the Camas City limits. In the light of recent business contraction (Karcher, Sharp, UL, Camas Mill), the City needs to be proactive in attracting new businesses to build in Camas for tax base growth and job creation.
- Camas is attractive for businesses due to tax benefits, no state income tax, close to Portland/Airport Outreach to companies that would be a good fit for relocation (High Tech, Medical Technology, Service Providers, Financial Services, Business Park, Light Industrial/Manufacturing).

4. What are the most significant challenges facing Camas today? Propose to address these challenges?

- Adequate staffing for Fire & Rescue/EMS at least 3 staff per truck/per call. Approve the additional 4 Fire positions regardless of Washougal support. Look at breaking the contract with Washougal in the future.
- Being able to provide high level City services in line with the citizens needs. Prioritize the most important services and closely evaluate the performance measures, operating efficiencies and service delivery models.
- Preserving the Heritage and Home Town Feel of Camas It's important to protect the unique beauty of the City and Area, while growing new businesses, restaurants, shops and services around town.
- Preserving Camas as an area that's livable and integrated with the outdoors expand the tree preservation program, continue to expand the integrated trail systems, outdoor programs and activities.
- Contraction in some larger businesses (Mill, UL, Sharp, Karcher). Assign members to perform business development activities to help attract new companies to Camas. The low hanging fruit is Multnomah, Clackamas and Washington Counties, as Oregon becomes an increasingly less attractive place to conduct business. Perform a Marketing effort to businesses outside the Portland Metro area.
- Increased traffic patterns as the City and population grows. Evaluate additional needs for more stop lights, speed suppression devices, sidewalks, speed lights and increased police patrols.
- Crown Park Pool closure is a local challenge. Evaluate alternatives for a new City Pool, comprehensive community event center. Develop corporate and endowment funding for a new facility.
- Ensure Camas is a cohesive community and provide transparency to the citizens Develop community engagement and communication strategies.

5. What forms of Public Service have you been involved in? Provide details regarding the dates and roles?

- Participated in the Prune Hill Park HOA for 8 years, including last 5 years as HOA President. Responsibility of all maintenance for green spaces, trail systems, private roads, trees, signage, home owner CC&R compliance and storm water facilities. Ensure Annual dues payments, balanced budget and funded reserve account.
- Volunteered to help run the Vancouver School District All Elementary District Track Meets in the Spring. Over the past 5 years, volunteered to be the co-Track race starter for every event.
- Youth sports coaching Youth Soccer, Baseball, basketball For a period of 5 years (2003-2007)
