## Good Morning -

The idea of installing a crosswalk at E. 1st & NE 3rd Ave has been discussed a few times over the years. Generally, we try to avoid installing crosswalks on major arterial streets unless there is a traffic signal at the intersection. There are exceptions, of course. An example is the crossing at NW 6th Ave and Ivy Street by the Little League fields. There's also another one to the east, by Young's Deli, at Drake Street that is serving a C-Tran Bus Stop. These crosswalks have an enhanced safety feature called a Rectangular Rapid Flashing Beacon (RRFB) in each direction. In the rare circumstances where we determine there's a significant need for a PED crossing at a location without a signal, the RRFB is generally regarded as the best way to draw attention to motorists that there are pedestrians ahead. The lights flash when the pedestrian pushes the button at the crossing.

From a legal standpoint, unless otherwise signed, intersections are legal places to cross traffic lanes. The existing intersection of NE 1st and NE 3rd is a legal pedestrian crossing. However, the question is really, "is it safe?" Installation of a crosswalk on a busy arterial can suggest that it's a safe place to cross, and the crosswalk itself can imply that a pedestrian is safe if they stay in the crosswalk, which may or may not be accurate.

I have relayed your request to our City Engineer, Jim Carothers. His current position on the issue is that there is a protected crossing two blocks to the east at Crown Road, and that the intersection at E. 1st and NE 3rd is too close to the traffic signal.

I hope I've answered your question.

> Hello Mr. & Mrs. Donald -
> Thank for your comments on the Lacamas Creek Pump Station Project.
> While the maps on the notice you received show construction activity on all of E. 1st Avenue, the actual work in this
area will be limited to the following items:
> 1) Installation of a 10" diameter pipe on the north side of E. 1st Avenue from NE 3rd Avenue to NE Joy Street, then
continuing north on Joy Street to an existing sewer manhole at NE 2nd and Joy. I expect the pipeline construction to be
completed in one work week, excluding the pavement restoration.
> 2) Sometime after the installation of the pipe mentioned in item #1 above, the entire street surface of E. 1st Avenue
from NE 3rd Avenue to NE Joy Street will have a 2" depth grind of the asphalt roadway, which will be followed by a 2"
depth asphalt pavement overlay. I expect the grinding of the roadway surface to be completed in 1-2 days. Asphalt
paving will occur on a different day sometime afterwards.
> Your ability to access SE King Street should not be significantly affected, although I'm suggesting that you should
generally turn left onto E. 1st Ave rather than heading east because there is much more work occurring near the
intersection of E. 1st Avenue and NE 3rd Avenue. The exception to this, will be the day that we do the asphalt paving on
E.1st Avenue. You will be notified prior to the asphalt paving so you have an opportunity to park on Joy Street or
another side street, if you expect to use your car the day of the paving. I expect the paving to be completed in one day.
> I note that work on the project will not start prior to October 1st of this year, and could easily be delayed until January
of 2020. The asphalt paving work is not likely to occur until late spring or summer of 2020. I hope I've answered your
questions. If I have missed something, please contact me as indicated below.
