# Project Updates and Accomplishments in Parks and Recreation (2019)

Legacy Lands Acquisition and Planning	The City has acquired approximately 141 acres. The project represents a significant forward- looking investment in the future of parks and open spaces in Camas and the realization of a long-standing community vision. Planning access and development for these properties is ongoing alongside infrastructure improvements. An assessment of the historic Ledbetter house is underway to evaluate the potential for future uses.
