

HEARINGS EXAMINER MEETING MINUTES - FINAL Thursday, April 13, 2017, 4:00 PM City Hall, 616 NE 4th Avenue

I. CALL TO ORDER

Joe Turner, Camas Hearings Examiner called the public hearing to order at 4:02 p.m.

II. INTRODUCTION AND INSTRUCTIONS

Mr. Turner gave a brief summary of the public hearing process. He explained that the role of the hearings examiner is to apply the City's existing laws and that state law requires applications be judged by the law at the time they were submitted. A written decision is generally submitted to the City within two weeks after the close of the record. Parties of record will be any party that submits comments into the record and those already on the parties of record list. Exhibits may be submitted to City staff at the hearing. Mr. Turner stated that he believes that he is an unbiased decision maker and disclaimed any ex-parte contacts, bias or conflicts of interest regarding the application. He described how the public hearing would be conducted and how interested persons could participate.

The new building will be 73,500 square feet and will include a gymnasium, commons, administration offices, classrooms, and play fields for approximately 700 students.

Until April 27, 2017 at 5:00 p.m., to allow for responses to traffic issues; Until May 4, 2017 at 5:00 p.m., to allow the applicant to respond and submit their final argument. If the applicant submits their final argument early, the Hearings Examiner will close the record upon receipt.

Mr. Turner added that a written decision will be issued in approximately 2 weeks after the close of the record.

The Hearings Examiner adjourned the public hearing at 4:45 p.m., with the record to remain open as noted above.
