A. Design Review Meeting for the Grass Valley Master Plan (DR18-04)
Details: The Design Review Committee held a public meeting to discuss the design criteria for the Grass Valley Master Plan. The Master Plan proposes three office buildings, one commercial retail / restaurant space, and 12 apartment buildings with associated accessory buildings. The Design Review Committee provided a recommendation to the City Council for final approval.
